## **ELECTION JUDGE ORDINANCE**

The following ordinance was presented to provide clarification to Election Judge Ordinance no. 24-03

An Ordinance Establishing Compensation for JUDGES OF ELECTION Ordinance No. 24-05

WHEREAS, the Illinois Election Code provides in 10 ILCS 5/13-10 that the respective County Boards shall establish salaries for Judges of Elections; and WHEREAS, Public Act 103-0008 has mandated an additional increase of \$20 per Judge of Election to be reimbursed to the County by the State Board of Elections which must be used to increase each judge's compensation and may not be used by the election authority to reduce its portion of a judge's compensation; and

to fulfill this requirement; WHEREAS, the State of Illinois has recently appropriated sufficient funds to the State Board of Elections

2024, at \$130 per day; and NOW, THEREFORE, BE IT RESOLVED, the Randolph County Board of Commissioners fixes the compensation of the judges of all primaries and elections, beginning with the General Primary Election of

completed a training course for Judges of Elections and taken the Precinct Election Manual Exam within BE IT FURTHER RESOLVED, additional compensation shall be paid to all judges who have satisfactorily

the past 2 years.

ELECTION JUDGE SALARIES. The compensation of Judges of Election is hereby set at \$130 per election. This additional \$20 shall be paid to all judges in accordance with the provisions of Public Act 103-0008 so long as reimbursement for the same is paid over to the County from the State Board of

Elections. Additionally, the compensation of Judges of Election having successfully completed a Training course and passed the Precinct Election Manual Exam administered by the County Clerk within the last two years is set at \$170 per election. The County Clerk may adopt uniform rules of compensating Judges of Election for such additional duties as receiving and returning ballots and supplies and reimbursing mileage of personal vehicles for such duties. (10 ILCSD 5/13-10)

AND BE IT FURTHER ORDAINED that this Ordinance shall take effect upon passage.
