RESOLUTION NO. 23-17

A RESOLUTION AMENDING RHSP RECORDING FEES

WHEREAS, Randolph County, Illinois ("County") is a body politic pursuant to the Illinois Constitution and the Illinois Counties Code; and

WHEREAS, 55 ILCS 5/3-5018 directs the County Board to collect a Rental Housing Support Program (RHSP) Fee for each recorded real-estate related document reflecting financial value; and

WHEREAS, State legislators recently passed HB3878 which will increase the RHSP Fee by an additional \$9.00; and

WHEREAS, the increase affects recording fees in all 102 counties throughout the State of Illinois and will take effect July 1, 2023; and

WHEREAS, said fee increase will affect the currently established Standard Recording Fee; and WHEREAS, the County Board now believes it to be in the best interests of the County that the schedule of miscellaneous fees in the Randolph County Code be amended in accordance with this Ordinance.

NOW, THEREFORE, BE IT ORDAINED THAT THE County Code (36-4-1) is amended as follows:

Section 1. The County Recorder shall collect the following recording fee for documents which are subject to the Rental Housing Subsidy Program fee:

"Standard Land Document

\$80.00" All other fees listed in the County Code shall not be affected by this Resolution.

That portion required by the State of Illinois to be used to fund the Rural Housing Support Fund shall be retained and transferred to the State of Illinois.
