Chairman Ronald G White called the meeting of the Randolph County Board of Commissioners to order at 9:00 AM on August 30, 2024 at the Boardroom.


### PLEDGE

The meeting started with the PLEDGE OF ALLEGIANCE. The pledge was led by Chairman White.





**RECESS**


