WHEREAS, Board of Commissioners of the County of Randolph, Illinois finds that it is necessary to set the compensation to \$20 for each day of necessary attendance at such court as jurors for the period beginning December 1, 2025; and

**WHEREAS**, Board of Commissioners of the County of Randolph, Illinois finds that it is necessary to set the mileage for jurors equal to the current federal mileage guidelines for the period beginning December 1, 2025.

**NOW, THEREFORE BE IT ORDAINED**, by the Board of Commissioners of the County of Randolph, Illinois that the juror fees and mileage be set beginning December 1, 2025, superseding all other ordinances and resolutions regarding Juror Pay.
