Chairman David Holder called the meeting of the Randolph County Board of Commissioners to order at 9:00 AM on April 10, 2026 at the Boardroom.


### PLEDGE



Ronald G White made a motion to approve raffle application no. 26-03 as presented. Andy Gerlach seconded the motion. The motion passed by vote.


### RECESS




