Chairman David Holder called the meeting of the Randolph County Board of Commissioners to order at 9:00 AM on June 18, 2026 at the Boardroom.

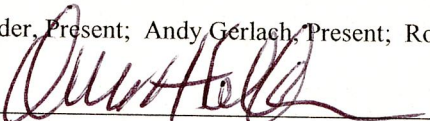
PLEDGE

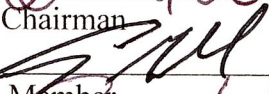
RECESS

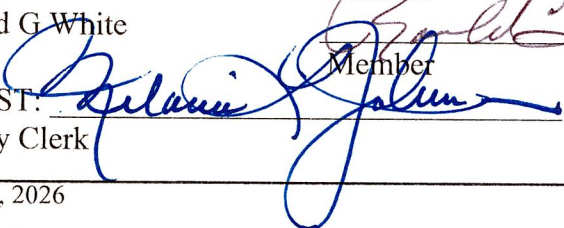
